THE NORTH AREA

The North Area of analysis covers the portion of Miami-Dade County generally defined by the area south of the Broward/Miami-Dade County line, east of NW 57th Avenue (Red Road) and NW 37th Avenue (connected by Gratigny Parkway), north of NW North River Drive/MacArthur Causeway and the Miami River Canal, and west of Biscayne Bay, West Dixie Highway (SR-909), US-1 (Biscayne Boulevard), and NE 6th Avenue. This area includes major sections of the cities of OpaLocka, Miami, North Miami, North Miami Beach, and Miami Shores, the Town of El Portal, and major neighborhoods including Carol City, Norland, and Biscayne Gardens, among others.

The North Area is traversed by several important corridors including I-95, Florida's Turnpike, SR-826/Palmetto Expressway, SR-860/Miami Gardens Drive, SR-7/US-441, SR-9 (27th Avenue), US-1/Biscayne Boulevard, SR-934/79th Street, SR-112 (Airport Connector), I-195/Julia Tuttle Causeway, Venetian Causeway, and I-395/US-41/MacArthur Causeway. Significant transportation improvement projects, already identified in the County's five year Transportation Improvement Program (TIP), include capacity improvements to SR-860 (Miami Gardens Drive), NW 17th Avenue, NW 62nd Avenue, and the implementation of an ITS information system on Interstate 95. The development of a 27th Avenue rail transit system is also under consideration.


The following pages contain illustrations of population and employment growth for the North Area, and the North Area transportation projects included in the Draft Needs Plan and that are being considered for inclusion in the 2020 Long Range Transportation Plan (2020 LRP). The 2020 Long Range Transportation Plan, currently under development, is a compilation of projects recommended for implementation between now and 2020 to meet the growing transportation needs of the area. This list of projects is in addition to those listed in the County's approved five-year Transportation Improvement Program (TIP). The Draft Needs Plan presented in this document includes those projects that are currently being considered for inclusion in the final Plan. Inclusion in the Plan will be determined based on need for the improvement and funding availability. The Draft Needs Plan list of projects is presented on a map and table in the following pages.

The following table and maps depict some demographic information pertaining to the North Area.




Population Growth 1990 to 2020 North Area
