Dear Ms. Boucle and Mr. Gastesi:

The Florida Department of Transportation (FDOT) is pleased to inform you that the selection process for this year's Transportation Alternatives (TA) Cycle has concluded. This process was a collaborative effort between FDOT, Miami-Dade Transportation Planning Organization's (TPO) committees, and Monroe County's evaluation committee. Please find the attached list of projects that are recommended for programming in FDOT's Tentative Work Program. Projects are programmed dependent on project readiness and funding availability. Funding is subject to the availability of federal funds and an annual appropriation by the legislature (the spending authority).

Programming of Miami Dade County's projects is pending the TPO Governing Board's approval. Once approved, the TPO will provide notification of the selection status to the various Miami-Dade agencies that applied for project funding. FDOT will notify the appropriate Monroe County agencies of their selection status.

We appreciate the time and effort that all applicants put into preparing and presenting their projects to our District's Scoping Committee. FDOT remains committed to the Transportation Alternatives program and looks forward to our continued collaboration with our stakeholders in improving the project selection and prioritization process.
